ENSURING FREE AND EFFECTIVE CIVIL SOCIETY PARTICIPATION IN THE UN SYSTEM

The WFUNA Plenary Assembly,

Acknowledging that on the 75th anniversary of the United Nations, in the midst of the COVID-19 pandemic, UN Member States pledged to strengthen global governance for present and future generations. They requested that the Secretary-General report back with recommendations to respond to current and future challenges (UN75 declaration - A/RES/75/1);

Noting that in September 2021, the Secretary-General responded with his report, Our Common Agenda, a wake-up call to speed up the implementation of the Sustainable Development Goals and propel the commitments contained in the UN75 Declaration;

Recalling the report called for a Summit of the Future to forge a new global consensus on readying ourselves for a future rife with risks but also opportunities. The General Assembly welcomed the submission of Our Common Agenda and decided to hold the Summit on 22-23 September 2024;

Recognizing that an action-oriented Pact for the Future is expected to be agreed by Member States through intergovernmental negotiations on issues they decide to take forward. This Pact will guide the work of the organization for the coming decades;

Recalling that this year the Secretary-General issued eleven Policy Briefs containing more detail on certain proposals from *Our Common Agenda* to be negotiated and finally included in the action-oriented *Pact for the Future*. These proposal include a forward-looking proposal on sustainable development and financing for development; international peace and security; science, measures beyond GDP, technology and innovation and digital cooperation; education and youth and future generations; outer space, emergency platforms and transforming global governance;

Recalling UNGA resolution A/68/428, Article VI.85 commending the World Federation of United Nations Associations and its more than 100 national United Nations associations for the valuable contributions they have made during the past years through their global activities in the mobilization of popular support for the United Nations and calling for continued collaboration between the World Federation and the Department of Public Information in support of their complementary objectives;
