• Platform workers and social protection: International developments

Summary: This article examines the key aspects of social protection that platform workers need. It also considers the problems associated with determining the proper employment status of platform workers that is essential to establish their social security and labour rights and goes on to point out that at present there is a lack of clear legal frameworks governing digital platforms that has led to many labour-related disputes. In response, several countries – such as Belgium, Italy, and Spain have introduced legislative measures to clarify the criteria used for determining the existence of an employment relationship on digital platforms. This article also mentions actions taken by Indonesia to provide social protection to platform workers.
