### Organization of Work of the First and Second Committees

#### Note by Secretariat

##### Allocation of items

1. The agenda items allocated by the General Assembly to the First and Second Committees are listed in the General Assembly Provisional Agenda (A (WIMUN New York)/7/150). Background information on item 3 (Protection of global climate for present and future generations of humankind) and agenda item 4 (Lethal Autonomous Weapons) may be found in an Informal Note prepared by UNODA Geneva and a Report of the Intergovernmental Panel on Climate Change, respectively, which have been circulated to Member States beforehand.

##### Length of statements

3. The Committee recommends a time limit of 1 minute 30 seconds for individual Member States during the General Debate in the First and Second Committees.

Unless otherwise specified, six meetings will be held from 01:30 p.m. – 05:30 pm, 07:00 p.m. – 09:30 p.m. on January 31; 09:00 a.m. – 12:00 p.m., 01:30 p.m. – 05:30 p.m., 07:00 p.m. – 08:30 p.m. on February 1; and 09:00 a.m. – 12:00 p.m. on February 2. In this connection, the

Committee decides to remind delegations that punctuality is of the utmost importance in the interest of ensuring an effective and orderly organization of work.

### **Informal Consultations**

5. During the second informal meeting, delegates will draft resolutions in Regional Groups and then merge the different drafts until there is only resolution on the item. After introducing the resolutions, delegates will return to informal consultations to review the drafts line by line and propose amendments.
6. In accordance with established practice, informal consultations may be used for expressing general observations on the proposals The Bureau may serve as, or appoint, facilitators in order to contribute to the process of reaching consensus.
