Programme of Work

Note by Secretariat

The draft programme of work of the first session of the Global Model WHO, which is contained in the Annex, has been prepared in order to facilitate the Assembly's consideration of items contained in its provisional agenda for the session in document A2/1.

Length of statements

1. The Assembly recommends a time limit of 2 minutes for individual Member States and 3 minutes for delegates speaking on behalf of regional groups during the General Discussion.

Informal Consultations

2. During the first informal meeting of Committee A, delegates will draft resolutions in Regional Groups and then merge the different drafts until there is only one resolution on each agenda item. After tabling a resolution, delegates will return to informal consultations to review it line by line and propose amendments.
3. The Bureau may serve as, or appoint, facilitators to contribute to the process of reaching consensus. If consensus is not reached on any of a resolution in the time allotted for informal negotiations, one or more delegates may request that it be put to a vote during the final formal meeting.

Conclusions of the work of the Assembly

4. Bearing in mind the number of meetings scheduled for the Global Model WHO, the Assembly sets a target date of 1 November 2024 at 12:00pm CET for the conclusion of its work.
