Youth shaping a sustainable, just and peaceful world for future generations

Amid current challenges and transitions for the international community; shaping a sustainable, just, and peaceful world is pivotal for the future. As part of the largest generation of youth in history, we all have a crucial role to play in supporting international efforts to promote global peace, sustainability, and justice. The United Nations has recognized the power of young people's voices by introducing them to a world of diversity, a world in which different points of view are heard and different cultures are bridged. Because it is the concert of all these different voices that have the power to bring about real change.

As recently affirmed by the UN Secretary-General António Guterres, youth participation within the UN poses both opportunities and challenges. Adopted by the General Assembly in 2015, the 2030 Agenda for Sustainable Development (2030 Agenda) acknowledges that cooperation and multilateralism are necessary to achieve the 17 SDGs, emphasizing the rising of social and economic inequalities. The latest SDG Report reveals that younger generations are the most affected by those disparities in a variety of scenarios: from poverty and food insecurity to unemployment and salary unevenness. On the one hand, difficulties are not limited to access to decent jobs but also to their engagement within institutions, being under-represented in every parliament in the world (except Europe). On the other hand, the global issue of climate change has allowed them to make their voice heard by actively leading initiatives to accelerate the transition to a greener future.

Even though some improvements have been achieved to even out all the imbalances; the phenomenon of inflation and the COVID-19 pandemic have negatively impacted the youth advancement towards the SDGs. Strengthening the means of implementation and revitalizing the Global Partnership for Sustainable Development represents the essential goal of enhancing youth transition into the workforce and citizen participation in the local decision-making processes. Fostering cooperation among local authorities and the private sector to improve employment levels, improving the quality of education, and allocating national funds to youth programs are only some of the urgent measures to be adopted by 2030.

Key Points and Main Issues

Delegates discussing "Youth shaping a sustainable, just, and peaceful world for future generations" at a Model UN conference should be aware of the following main issues:

1. Climate Change and Environmental Sustainability:

- Youth's Role in Climate Action: Understanding how young people can influence climate policies and support renewable energy, conservation, and sustainable practices.
- Global and Local Impacts of Climate Change: How climate change affects different regions, with particular attention to vulnerable populations and ecosystems.
- **Climate Justice**: Awareness of the disproportionate impact of climate change on marginalized communities and the need for policies that prioritize equity.

2. Peace and Conflict Resolution:

- Global Conflicts and Their Impacts on Youth: Examining how conflicts impact young people and how youth can participate in peacebuilding efforts.
- Youth in Peacebuilding and Advocacy: Understanding the importance of youth voices in promoting diplomacy, intercultural understanding, and conflict resolution.
- Weapons and Violence Prevention: Discussing ways to advocate against the proliferation of arms, violence, and radicalization among young people.

3. Social Justice and Human Rights:

- Inequality and Social Justice: Addressing global disparities, including access to education, healthcare, and resources, and how these affect youth opportunities.
- Human Rights and Gender Equality: Understanding the importance of promoting gender equality, LGBTQ+ rights, and the protection of vulnerable groups.
- Education and Empowerment: Exploring how education plays a central role in empowering youth and closing inequality gaps worldwide.
- 4. Youth's Role in Economic Development:
- Youth Unemployment and Economic Opportunity: Discussing the high rates of youth unemployment globally and how sustainable development can create economic opportunities.
- Entrepreneurship and Innovation: Encouraging ideas about how young people can drive innovation and entrepreneurship in sustainable industries.
- **Digital Literacy and Technology**: Examining how technology can empower youth but also considering the risks, such as the digital divide, data privacy, and ethical technology use.

5. Good Governance and Youth Representation:

- Youth Involvement in Politics and Policy: Emphasizing the importance of youth voices in political decision-making and how to advocate for greater youth representation in government.
- **Corruption and Accountability**: Recognizing the challenges posed by corruption and the need for transparent, accountable institutions that work in the interests of young people and future generations.
- **Global Citizenship**: Understanding the concept of global citizenship and how it encourages youth to be active, responsible members of the global community.
- 6. Health and Well-being:
- Mental Health: Addressing the mental health challenges youth face, exacerbated by climate anxiety, social issues, and the pressures of modern life.
- Healthcare Access: Discussing the need for equitable access to health services, especially reproductive health, in order to support healthy and empowered youth.
- Youth and Pandemic Preparedness: Reflecting on the lessons learned from COVID-19 and the role of young people in addressing global health crises.
- 7. The Role of International Institutions and Partnerships:
- UN Sustainable Development Goals (SDGs): Familiarizing with the SDGs, especially those related to youth empowerment, and understanding how they guide international development efforts.
- Global Partnerships and Collaboration: Recognizing the value of partnerships between governments, NGOs, and the private sector to tackle these challenges collaboratively.
- Youth Advocacy Networks: Learning about international youth networks and initiatives that support young leaders and amplify youth voices on the global stage.
- 8. Technology and Innovation for a Sustainable Future:
- Climate Tech and Sustainable Innovation: Discussing how youth can support the development and adoption of new technologies for sustainability, such as clean energy and sustainable agriculture.
- Digital Activism and Online Communities: Exploring how youth can use social media and digital platforms for advocacy, activism, and creating awareness around global issues.

By understanding these issues, delegates can discuss effective ways for youth to drive positive change, participate in governance, and advocate for policies that prioritize sustainability, justice, and peace for future generations.

ECOSOC Youth Forum 2024



Summary: The Economic and Social Council (ECOSOC) Youth Forum is an annual initiative of the President of the Council. It has evolved into a key platform where young people can contribute to policy discussions at the United Nations through their collective ideas, solutions and innovations. As the main platform for youth to share their ideas at the global level, the Forum allows representatives of youth-led and youth-focused organizations and networks, youth advocates and other youth stakeholders to dialogue with Member States, and to explore ways and means of promoting youth development and engagement. The Forum this year focused on providing an opportunity for a rich exchange of views and ideas on innovative solutions to issues of relevance to young people on the implementation of the 2030 Agenda which is very much related to the topic the Youth Council will focus on. Informal Summary of ECOSOC Youth Forum

2024

Summary: The 2024 Economic and Social Council (ECOSOC) Youth Forum, held from April 16 to 18 at the United Nations headquarters in New York, convened over 1,000 young leaders from around the globe to engage with Member States, policymakers, and various stakeholders. The Forum's theme, "Reinforcing the 2030 Agenda and eradicating poverty in times of multiple crises: the effective delivery of sustainable, resilient, and innovative solutions," guided discussions on Sustainable Development Goals (SDGs) under review in 2024, including no poverty (SDG 1), zero hunger (SDG 2), climate action (SDG 13), peace, justice, and strong institutions (SDG 16), and partnerships for the goals (SDG 17). Participants shared innovative ideas and solutions addressing challenges such as climate change, inequality, and conflicts.

UN Secretary-General António Guterres emphasized the critical role of youth in shaping a sustainable future, highlighting the establishment of a new UN Youth Office to enhance youth engagement in decision-making processes.

The ECOSOC Youth Forum continues to serve as a vital platform for young people to influence global policy discussions, ensuring their perspectives and solutions are integral to achieving the 2030 Agenda for Sustainable Development

HLPF Paper: Sectoral Paper & 'ECOSOC to HLPF' P

2024

Summary: The Youth Sectoral paper highlights the following key points:

- 1. Global Crises and Systemic Failures: 2024 is marked by unprecedented global crises, including wars, conflicts, climate change, and human rights violations. These crises expose the fragility of global systems, inequalities, inadequate health systems, and the failure of traditional governance approaches.
- 2. Disaster Risk and Economic Loss: Disasters not only disrupt socio-economic systems but also exacerbate long-term vulnerabilities, especially among marginalized groups. The Sendai Framework's Global Target C emphasizes reducing disaster-related economic losses as essential for resilience.
- 3. Call for Structural Reforms: There is an urgent need to rethink and realign global systems and values to address these challenges. Structural reforms and prevention-oriented policies must prioritize inclusivity, intersectionality, and resilience-building to achieve the SDGs.
- 4. Youth Engagement and Intergenerational Justice: Persistent barriers like agebased discrimination hinder meaningful youth participation in decisionmaking. Genuine intergenerational collaboration is vital to overcome this injustice.
- 5. **SDG Progress and Missed Targets:** The current progress towards the 2030 Agenda is insufficient and misaligned with aspirations. Poverty, marginalization, and vulnerability are systemic failures requiring innovative, intersectional solutions.
- 6.Focus on Early Warning Systems: The Early4All initiative by the UN Secretary-General aims to provide universal early warning systems by 2027, highlighting the importance of anticipatory actions to mitigate risks and reduce losses.

The paper calls for practical, stakeholder-driven recommendations to collectively address systemic issues, realign priorities, and mobilize towards the 2030 Agenda with a focus on inclusivity, resilience, and sustainable solutions.
