Organization of Work of the Assembly

Note by Secretariat

- The agenda item allocated by the General Assembly to the Sixth Committee is listed in the General Assembly Provisional Agenda (A/(WIMUN Singapore)/12/150). Background information on the agenda item provided in the Secretary-General's Report on "Measures to eliminate international terrorism" has been circulated to Member States beforehand.
- 2. The draft Programme of Work of the Sixth Committee is available in the Annex.

Length of statements

3. The Committee recommends a time limit of 1 minute for individual Member States and 1 minute 15 seconds for delegates speaking on behalf of regional groups during the General Debate.

Conference facilities and meetings arrangements

4. Taking into account the availability of conference services for the Sixth Committee, six meetings have been scheduled. Unless otherwise specified, five meetings will be held from 1:30 p.m. – 6:00 p.m., on 15 July 2025; 9:00 a.m. – 12:00 p.m., 1:30 p.m. – 5:30 p.m., 7:00 – 9:00 p.m. on 16 July 2025; and 9:00 a.m. – 12:00 p.m. on 17 July 2025. In this connection, the Committee wishes to remind delegations that punctuality is of the utmost importance in the interest of ensuring an effective and orderly discussion of the assigned agenda item.

Informal Consultations

5. During information consultations, delegates will draft resolutions in Regional Groups and then merge the different drafts until there is only resolution on the agenda item. Delegates will then review the draft line by line in order to propose amendments.

6. In accordance with established practice, informal consultations may be used for expressing general observations on the proposals The Bureau may serve as, or appoint, facilitators in order to contribute to the process of reaching consensus. If consensus is not reached on the draft resolution, it will be withdrawn.

Conclusion of the work of the Sixth Committee

7. Bearing in mind the number of meetings scheduled for the Committee, a target date of 17 July 2025 at 12:00 pm is set for the conclusion of its work.
