Organization of Work of the Assembly

Note by Secretariat

1. The draft Programme of Work of the third session of the WIMUN World Health Assembly, which is contained in the Annex of this document, has been prepared in order to facilitate the Assembly's consideration of agenda item 2.1, "Mental health, youth and learning environments." The provisional agenda for the session is contained in document A3/1.

Length of statements

2. The Assembly recommends a time limit of 1 minute for individual Member States and 1 minute 15 seconds for delegates speaking on behalf of regional groups during the General Discussion.

3. Taking into account the availability of conference services for the World Health Assembly, five meetings have been scheduled. 1. During information consultations, delegates will review a Zero draft line by line in order to propose amendments.
2. In accordance with established practice, informal consultations may be used for expressing general observations on the draft resolution. The Bureau may serve as, or appoint, facilitators in order to contribute to the process of reaching consensus.

3. Bearing in mind the number of meetings scheduled for the World Health Assembly, a target date of 31 October 2025 at 12:30pm is set for the conclusion of its work.
