## Organization of Work of the Assembly

#### **Note by Secretariat**

1. The draft Programme of Work of the third session of the WIMUN World Health Assembly, which is contained in the Annex of this document, has been prepared in order to facilitate the Assembly's consideration of agenda item 2.3, "Health and migration." The provisional agenda for the session is contained in document A3/1.

#### Length of statements

2. The Assembly recommends a time limit of 1 minute for individual Member States and 1 minute 15 seconds for delegates speaking on behalf of regional groups during the General Discussion.
