Marine Plastic Litter and Microplastics

The United Nations Environment Assembly,

PP1 *Noting* with concern that marine plastic litter and microplastics have become one of the most urgent and imminent threats to the health of our oceans and the health of land and water ecosystems, jeopardizing the survival of marine and land animals, as well as the lives of people around the world, **Agreed ad ref**

PP2 *Noting* that the global production of plastics is around 280 million tonnes per year, with 20 million deposited in the oceans all over the world, resulting from human consumption, **[AUS DEL PP2][ANG, CUB, BRA, CHI, GER, PAR RET]**

PP2 bis CHI: *Noting* that 280 million tons of plastic is produced globally per year, 20 million tons is deposited in oceans all over the world as a result of human consumption,

PP3 **[UK REP: *Acknowledging* that]** human rights and the environment are intertwined; human rights cannot be **[ANG REP: *guaranteed enjoyed*]** without a safe, clean and healthy environment,

PP4 *Underlining* the urgent need to **[CHI, BRA, ANG, RUS DEL:]** implement the United Nations Environment Assembly resolutions 1/6, 2/11 and 3/7, the Honolulu Strategy in 2011 and the last few proposals embraced by the international community in the eleven non-binding resolutions discussed during the Nairobi meeting of the UNEA in 2017, **[AUS MOVE PP4 to PP1] [BOL DEL:PP4][KEN RET PP4]**

PP5 *Recalling* also the Sustainable Development Goals (SDG'S) number 6, 7, 12 and 14, which established the purposes of the United Nations in tackling the **[UK REP: *issue*], [MEX, AUS, PER DEL: PP5][CUB, KEN, USA RET PP5][NOR, RUS MERGE PP5 and PP4]**

PP6 **[ANG REP: *Considering*]** the need for an international response to marine pollution through collaboration and cooperation,

PP7 *Recognising* the inadequacy of member states' waste management systems and policies, **Agreed ad ref**

PP8 *Commending* member states past actions in developing new technologies, **Agreed ad ref**

PP9 [MEX REP: *Keeping in mind*] the economic divide between developed and developing [BRA REP: countries] across the globe,

PP10 *Deeply concerned* that this contamination problem problem could lead to [PER, AUS REP: irreversible] [CHI REP: irreconcilable] damages for global ecosystems, the developing countries want to [AUS REP: increase] [KEN, ANG, GER RET] a hand in favour of innovation promoting transparency and cooperation on an educational level,
