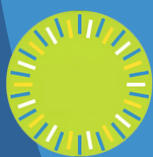

# Amendment Worksheet

General Comments: Insert the amendments you would like to the text of your outcome document.

Each preambular paragraph (PP) and operative paragraph (OP) begin with two letters followed by a number (e.g., PP1, PP2, etc. or OP1, OP2, etc). Put that reference in column A. Fill in the empty spaces as needed.

In Column B, put in the type of amendment you wish to propose. Consult the document “Seven Ways to Amend” to identify what type of amendment you would like to propose. If you want to insert a new paragraph, write in Column A “new paragraph” and where it should be placed (see example).

In Column C, put the actual change you want to make.

In Column D, indicate the how important the amendment is to your delegation by assigning a number from 1-4 from the list below to indicate if the amendment is low, medium or high priority:

1. low priority means that the change you are proposing has minimal impact on the resolution,
2. medium priority means you should make your best efforts to get the proposed language or similar language included however, if it is not accepted it should not affect your support of the resolution,
3. high priority means that proposed change should be strongly encouraged and
4. redline, the highest level of priority should be indicated for those changes that if not accepted would result in not sponsoring the resolution.
