Organization of Work of the Assembly

Note by Secretariat

1. The draft organization of work of the sixth session of the World Health Assembly, which is contained in the Annex, has been prepared in order to facilitate the Assembly's consideration of agenda item 3, "Vaccine Hesitancy in the Context of Behavioral Sciences".

Length of statements

2. The Assembly recommends a time limit of 1 minute for individual Member States speaking during the General Discussion.

Conference facilities and meetings arrangements

3. Taking into account the availability of conference services for the World Health Assembly, five meetings have been scheduled. Unless otherwise specified, six meetings will be held from 1:30 p.m. - 5:00 p.m., on 12 August 2026; 9:00 a.m. – 12:00 p.m., 1:30 p.m. – 5:30 p.m. on 13 August 2026; 9:00 a.m. – 12:00 p.m., 1:30 p.m. – 5:30 p.m. on 14 August 2026; and 9:00 a.m. – 12:00 p.m. on 15 August 2026. In this connection, Committee A wishes to remind delegations that punctuality is of the utmost importance in the interest of ensuring an effective and orderly discussion of the assigned agenda item.

Informal Consultations

1. During the first informal meeting, delegates will draft a Resolution in Regional Groups and then merge the different drafts until there is only one Draft Resolution. Committee A will then return to informal consultations to review the Draft Resolution line by line and propose amendments.
2. In accordance with established practice, informal consultations may be used for expressing general observations on the draft resolution. The Bureau may serve as, or appoint, facilitators in order to contribute to the process of reaching consensus.

Conclusion of the work of the Assembly

3. Bearing in mind the number of meetings scheduled for the World Health Assembly, a target date of 15 August 2026 at 12:00 p.m. is set for the conclusion of its work.
